Di Vittorio,307/2- 20099 Sesto San Giovanni (MI), as data controller, informs you that, in compliance with Legislative Decree 196/2003 and the European Regulation 679/2016 (so called GDPR) which regulates the protection of personal data and their free circulation, your personal data will be treated in compliance with the aforementioned legislation, based on the principles of correctness, lawfulness, proportionality of interests and transparency as well as the protection of your privacy and your rights, for the purposes, with the methods and terms and conditions indicated below.

1. Propose, methods and legal bases of data processing

2. Nature of data collection and consequences of failure to provide data

The right to obtain a copy of the personal data being processed;

The interested party has also the right to obtain:

- Updating, rectification or, where interested, integration of data;
- The cancellation, transformation into anonymous form or blocking of data processed in violation of the law, including those for which conservation it's not necessary in relation to the purposes for which the data were collected or subsequently processed;
- The attestation that the operations referred to in letters a) and b) have been brought to the attention, including as regards their own content of those to whom the data have been communicated or disseminated, except in the case where such fulfilment proves impossible or involves the use of means that are manifestly disproportionate to the protected right;
